**Call to Order**

**1. Annual Audit Report: Bill Hancock: Brittingham, Brown, Prince & Hancock LLC CPA** – Mr. Hancock stated that there were no noncompliance incidents in last year’s budget and that time was taken in preparing the budget and budget spending was in proper bounds. He also stated that the Town was on time getting reports to the SC Treasurer’s office. Mayor Gaddy asked when the final report would be ready and Mr. Hancock stated in several weeks.

**2. Capital Expenditure Request – Water Plant:** Mr. Wood stated that several items needed to be purchased in the Water Plant.....replacement Air Scour Blower, Plant Emergency Light Replacements, Chlorine Gas Cylinder Scales and a pump that needs overhauling. Councilman Klaus made a motion to approve these purchases with a second by Councilman Sanders. All voted aye.

**3. Capital Expenditure Request – Gas, Water & Sewer Department:** Purchase of a backhoe is needed and Blanchard was recommended. This would total \$39,250 plus tax.

**4. Roof for Public Safety** – Bids will go out for a roof replacement and to replace/repair interior damage caused from leaking roof.

**Executive Session**

**1. Mayor Pro tem Wilkes read Resolution R012114 – “A RESOLUTION AUTHORIZING THE TOWN OF WINNSBORO TO EXTEND THE 1994 WATER SERVICE AGREEMENT WITH MID-COUNTY WATER COMPANY INC. FOR A PERIOD OF 60 DAYS AFTER ITS EXPIRATION ON FEBRUARY 15, 2014, SO AS TO PERMIT THE PARTIES TO CONDUCT GOOD FAITH NEGOTIATIONS FOR A NEW WHOLESALE WATER AGREEMENT, OR ALLOW CONTINUED SERVICE FOR A PERIOD OF 12 MONTHS UNDER A SEPARATION OF SERVICE PLAN APPROVED BY DHEC.**

**2. COUNCIL RECOMMENDED AWARDED WATEREE CONSTRUCTION COMPANY FOR THE CONSTRUCTION OF THE BLYTHEWOOD PUMP STATION. TOWN OF WINNSBORO AND FAIRFIELD COUNTY WOULD PAY HALF EACH. COUNCILMAN KLAUS SECONDED AND ALL VOTED AYE.**


With no further business to discuss, Councilman Klaus made a motion with a second by Councilman Miller that the meeting be adjourned. All voted aye.
