The Town of Winnsboro shall not be held liable for any loss or damage, resulting from defects in the installation of any or all services in which accidents can occur at the above premises.

The applicant, if the owner of the property, grants the Town the right to free access at the above location for service repairs, reading of meters, etc., and also removal of Town property if service is discontinued.

The Town also reserves the right to disconnect services if the above applicant owes any past balances that were accrued at any other location. The Town also reserves the right to transfer balance(s) from a previous account if applicant has a past balance from another location. The Town also reserves the right to increase utility deposits to the maximum if the applicant continues to have delinquent payments or numerous cutoffs for non-payment of account. Deposits are refunded after two (2) years if there are no late payments. The applicant agrees that this application is subject to the "General Terms and Conditions" as a part of this agreement.

**If Co-Signer is used and bills are not paid promptly the Co-Signer will be responsible for payment of the bill.**

By signing this application for Electric/Gas/Water/Sewer, the applicant/co-signer agrees to pay all cost of collections of the applicant's unpaid bills. The Town of Winnsboro has the right pursuant to the South Carolina Setoff Debt collection Act to collect any sums due and owed by the applicant through offset of the applicant's/cosigner's state income tax refund. If the Town of Winnsboro chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant/co-signer agrees to pay all fees and costs incurred through the setoff process, including fees charged by the Department of Revenue, The South Carolina Association of Counties, The Municipal Association of South Carolina and/or the Town of Winnsboro. If the Town of Winnsboro chooses to pursue debts in a manner other than setoff, the applicant/co-signer agrees to pay the costs and fees associated with the selected manner as well.
